General information

When you access our website, information of all kinds is automatically collected. This information (server log files) relates e.g. to the type of web-browser, the operating system used, the domain name of your Internet service provider and similar. This exclusively concerns information that does not allow for any conclusions relating to your person. This information is technically required in order to correctly provide the content you requested from web pages and therefore results in connection with the use of the Internet. We can statistically analyse anonymous information of this kind in order to optimise our website and the underlying technology.

The operators of these pages take the protection of your personal data very seriously. We handle your personal data in a confidential manner and in accordance with legal data protection regulations as well as the General Data Protection Regulation (DSGVO).

We wish to point out that data transfer on the Internet (e.g. when communicating via e-mail) may contain security holes. It is not possible to seamlessly protect your data against access by third parties.

You have the following rights in accordance with the General Data Protection Regulation (DSGVO):

Right of information: In accordance with Article 15 DSGVO, you can demand confirmation as to whether data relating to you is processed. If this is the case, you have a right to information pertaining to the information that was processed.

Right to the revocation of consent: To the extent your personal data is processed on the basis of your consent, you have the right, in accordance with Article 7 DSGVO, to revoke this consent at any time.

Right of objection: To the extent your personal data must be processed in order to uphold the legitimate interests of our company, you can object to its processing at any time in accordance with Article 21 DSGVO.

Right of erasure: If you have revoked your consent, objected to the processing of your personal data (and there are no overriding legitimate grounds for processing), your personal data is no longer required for processing purposes, there is a corresponding legal obligation or your personal data has been processed unlawfully, you have the right to demand that your personal data is erased in accordance with Article 17 DSGVO.

Right of rectification: If your personal data has been incorrectly processed, you have the right, in accordance with Article 16 DSGVO, to immediately demand the rectification of this data.

Right to the restriction of processing: Subject to the prerequisites of Article 18 DSGVO, you have the right to demand the processing of your personal data be restricted.

Right of data portability: In accordance with Article 20 DSGVO, you have the right to receive the personal data you provided in a structured, conventional and machine-readable format.

Right of complaint: In accordance with Article 13 DSGVO, you have a right to complain to the competent supervisory authority.

Revocation of your consent to data processing

Many data processing operations are only possible with your express consent. You can revoke consent you have granted at any time. An informal message in an e-mail to us is sufficient. The revocation shall not affect the lawfulness of the data processing up to the time of revocation.

Right of complaint toward the competent supervisory authority. In the event of violations of data protection law, the party affected shall have a right to complain to the competent supervisory authority. The competent supervisory authority for matters pertaining to data protection law is the state data protection officer of the federal state in which our company is based.

Information, blocking and erasure

In connection with applicable legal provisions, you have the right to be issued information, free of charge, regarding your personal data that is saved, its origin and recipients, the purpose of data processing and, if applicable, a right to the rectification, blocking or deletion thereof. You can contact us at any time at the address specified in the website credits in this regard as well as with further questions relating to this topic.

SSL and/or TLS encryption

For reasons of safety and in order to protect the transfer of confidential content such as orders or inquiries you send to us as the site operator, this site uses SSL and/or TLS encryption. You can recognise an encrypted connection in that the address bar of the browser switches from "http://" to "https://" as well as the lock symbol in your browser bar.

If SSL and/or TLS encryption is activated, the data you send to us cannot be read by third parties.

E-mail and contact form

We will only save personal data, which we process in connection with a general contact inquiry sent via e-mail or our contact form as long as is necessary for the respective correspondence.

If you forward us inquiries with the contact form, we will save your data from the contact form including the contact data you specified therein in order to process your inquiry and also in the event of subsequent questions. We will not pass on this data without your consent. The data provided in the contact form will therefore be processed only on the basis of your consent (Art. 6 para. 1 lit. a DSGVO). You can revoke this consent at any time.

An informal message in an e-mail to us is sufficient. The lawfulness of the data processing operations that were performed up to revocation shall

not be affected by the revocation. The data you entered in the contact form will remain with us until you ask that we erase it, revoke your consent to its storage or the purpose for data storage ceases to apply (e.g. once your inquiry has been processed).

Compulsory legal provisions – in particular retention periods – remain unaffected.

Server log files/ statistical evaluations

Log files concerning the user's access to the pages will be kept on the services, in particular the static and/or dynamic IP address of the accessing user, the pages accessed, browser type, referrer addresses, access data and access time. We can access this data. The data contained in the log files is used exclusively for statistical purposes. The user is not identified to the extent not prescribed by law.

The basis for data processing is Art. 6 para. 1 lit. b DSGVO, which permits the processing of data for the fulfilment of a contract or precontractual measures.

IP anonymization

We have activated the IP anonymization function on this website. As a result, your IP address will be shortened by Google within the member states of the European Union or in other states party to the Agreement on the European Economic Area before being transferred to the USA. Only in exceptional cases will the full IP address be transferred to a server of Google in the USA where it is shortened.

As commissioned by the operator of this website, Google will use this information to analyse your use of the website in order to compile reports on website activities and to provide further services associated with website use and Internet use vis-à-vis the website operator. The IP address transferred by your browser in connection with Google Analytics will not be combined with other data by Google.

Browser plugin

You can prevent the storage of cookies by configuring your browser software accordingly; however, please be advised that in such a case you may not be able to use all functions of this website fully. Third-party services and content (e.g. GoogleMaps)

It is possible that third-party content is embedded in our website such as videos from YouTube, map material from Google-Maps or RSS feeds. This always requires that the providers of this content (hereinafter referred to as the "Third-party Providers") always observe the IP address of the users. After all, without the IP address, they would not be able to forward the content to the browser of the respective user. We endeavour to only use content whose respective provider only uses the IP address to relay the content. However, we have no influence with respect to the saving of the IP address on the part of the third-party providers e.g. for statistical purposes.

Facebook plugins

This website may use multiple plugins from Facebook, Facebook Ireland Ltd., 4 Grand Canal Square, Grand Canal Harbour, Dublin 2, Ireland. You will recognise these plugins either by the blue "F" of Facebook, a "Thumbs up" sign or in that this plugin is marked with the word "Facebook". When you access this website, these plugins will establish a connection to the servers of Facebook and data will be transferred. On one hand, the information you see will be directly transferred to your browser by the servers and rendered there and, on the other hand, information relating to your visit to our website will be transferred to Facebook. If you have logged into Facebook, you can assign the information transferred directly to your account. If you interact with the functions of the plugin e.g. push the "Like" button, this information will be transferred by your browser directly to Facebook and saved there. The further processing of this information is the responsibility of Facebook; please refer to Facebook's privacy statement for the corresponding terms and conditions as well as the configuration possibilities. Google +1 button

Google web fonts

Cookies, that is, text files stored on your computer are used on this website. Persistent cookies recognise that your PC already connected to a web offering while "session cookies" save the last offerings viewed. "Session cookies" are deleted after the end of a session. In general, you can accept or rule out the setting, that is, the storage of cookies by configuring your browser accordingly.

Embedded videos

Youtube videos may be embedded on a number of our websites YouTube, LLC, 901 Cherry Ave., San Bruno, CA 94066, USA is the operator of the corresponding plugins. If you visit a page with the YouTube plugin, a connection will be established to the servers of Youtube. In the process, Youtube will be notified as to which pages you are visiting. Once you have logged into your Youtube account, Youtube can attribute your surfing behaviour to you personally. You can prevent this by logging out of your Youtube account beforehand. If a Youtube video is started, the provider uses cookies to collect information about the user behaviour. Anyone who has deactivated the storage of cookies for the Google ad programme does not have to expect such cookies to be created when they watch Youtube videos. However, Youtube will also store non-personal usage information in other cookies. If you would like to prevent them, then you must block the storage of cookies in your browser.

Social plugins

Social plugins of the providers listed below can be used on our websites. You can recognise the plugins in that they are marked with the corresponding logo.

With these plugins, information, which may include personal data, is sent to the service operator and, if applicable, used by said party. We prevent the unintentional and unwanted collection and transfer of data to the service provider by means of a 2-click solution. In order to activate a desired social plugin, it must be activated by clicking on the corresponding switch. Only once the plugin is activated, will the collection of information and its transfer to the service provider be initiated. We ourselves do not collect any personal data using the social plugins or concerning their use.

We have no influence on which data is collected by an activated plugin and how it is used by the provider. At present, it must be assumed that a directly connection is established to the services of the service provider and that at least the IP address and device-specific information is collected and used. There is also the possibility that the service providers attempt to save cookies on the computer used. Please refer to the privacy notes of the respective service provider to determine which specific data is collected in this respect and how it is used. Notice: If you are logged into Facebook at the same time, Facebook can identify you as a visitor to a certain page.

Google Adwords

Our website may occasionally use Google conversion tracking. If you have accessed our website via an ad placed by Google, Google Adwords will create a cookie on your computer. The cookie for conversion tracking will be created when a user clicks on an ad placed by Google. These cookies will lose their validity after 30 days and do not serve personal identification. If the user visits certain pages of our website and the cookie has not yet expired, we and Google are able to recognise that the user clicked on the ad and was forwarded to this page. Every Google AdWords customer will receive another cookie. Cookies can therefore not be traced via the websites of AdWords customers. The information obtained with the conversion cookies serves to create conversion statistics for AdWords customers, who have decided in favour of conversion tracking. Customers will learn about the total number of users, who have clicked on their ad and who have been forwarded to a page provided with a conversion tracking tag. However, you will not be provided with any information, which allows users to be identified personally.

Please note that you may not delete the opt-out cookies as long as you do not want measurement data be recorded. If you have deleted all your cookies in the browser, you must create the respective opt-out cookie again.
